Independent Assurance of S&P Global's Greenhouse Gas Emissions: ISAE 3000 statement

The nature of the assurance

This is a report by Corporate Citizenship for the corporate responsibility team at S&P Global.

Corporate Citizenship has undertaken **limited** assurance of selected environmental performance data as described below:

The assurance covers the period from January 1, 2017 to December 31, 2017.

S&P Global is entirely and solely responsible for the production and publication of the data assured, Corporate Citizenship for its assurance.

The data relates to S&P Global's owned and leased facilities under its operational control.

GHG quantification is subject to inherent uncertainty due to factors such as incomplete scientific knowledge about the global warming potential of different GHGs and uncertainty around the models and parameters used in estimating GHG emissions.

This engagement was performed in accordance with the International Standard on Assurance Engagement (ISAE) 3000 (Assurance Engagements other than Audits or Reviews of Historical Financial Information) and the relevant subject-matter specific ISAE for GHG data (ISAE 3410, Assurance Engagements on Greenhouse Gas Statements). Corporate Citizenship has complied with the requirements for independence, professional ethics and quality control as stipulated by ISAE 3000.

Assurance work performed

The assurance work was commissioned in April 2018 and was completed on June 20, 2018. Detailed records were kept of meetings, assurance visits and correspondence relating to the assurance. A team of three, led by an Associate Director, undertook the assurance and commentary process. A Director acted as adviser to the group. One additional team member reviewed hotel emissions in December 2018.

Corporate Citizenship's work has involved, but not been limited to, the following elements:

- In-depth management interview with key persons at CBRE responsible for S&P Global's environmental performance data in order to understand S&P Global's processes for management, reporting and performance improvement in these areas;
- 2. A review of the 2018 S&P Global Inventory Management Plan used for data collection and reporting;
- 3. A review of underlying data sources and substantiating evidence to support this year's reporting, in order to assess robustness of monitoring and reporting systems;
- 4. A review of year-on-year environmental performance trends to identify any significant changes in operational eco-efficiency and investigate the reasons behind these trends;
- 5. A review of GHG calculations for accuracy and consistency with best practice guidelines;
- 6. A review of group-wide data consolidation and reporting to check for errors or omissions in data analysis, consistency with underlying data sets and reasonableness of reporting.
